To all interested parties:

I am pleased to present the Maryland Port Administration's 2015 Foreign Commerce Statistical Report. This report is compiled mainly from foreign trade data produced by the U. S. Census Bureau.

This publication is produced annually by the Maryland Port Administration (MPA) to provide a consistent historical record of foreign trade moving through the Port of Baltimore. The official federal data used for this report does not include the location of U.S. shippers or importers. It is important to understand that the Port of Baltimore serves shippers and importers in numerous states in the Mid-Atlantic and Midwest. The data reported herein reflects cargo moving through the Port to or from these many states, not just cargo shipped by Maryland-based companies or individuals.

This report is focused almost exclusively on the Port's foreign commerce. The Port also moves substantial volumes of domestic cargo, which consists largely of raw materials, such as coal, petroleum and cement, which are transported within the Chesapeake Bay or to nearby East Coast ports.

I hope that this publication will serve as a useful reference on foreign commerce in the Port of Baltimore. # THE PORT OF BALTIMORE'S WATERBOURNE COMMERCE 2015

## Summary:

The Port of Baltimore consists of public marine terminals owned by the Maryland Port Administration (MPA) and privately owned marine terminals. Approximately 90% of all general cargo tons move through the MPA's public terminals, while the private terminals handled most of the Port's bulk commodities.

The Port of Baltimore's foreign cargo tons climbed 9.7% to 32.4 millions tons in 2015 while the overall value dropped to \$51.1 billion. The Port fared better than the nation as a whole, which saw overall cargo tons drop 1.7% and the value of foreign cargo decline by 10.6%.

Bulk cargo tons through Baltimore saw the biggest gains - with coal export tons increasing 9.6% from 2014. Imports of bulk products such as salt, gypsum and slag also saw large gains. Approximately 68% of all international cargo tons moving through the Port of Baltimore are in the form of bulk cargo.

The MPA set a record for the number of containers handled in 2015 while the Port of Baltimore also saw a record number of import automobiles. The strong dollar, weaker overseas economies and lower commodity prices took a toll on general cargo exports.

Domestic container cargo using the MPA's public terminals totaled 327,587 tons in 2015 and is not included in the general foreign cargo numbers. This is primarily containerized cargo that is barged to/from Norfolk.

The Port of Baltimore maintained its ranking as the 13<sup>th</sup> largest port in the USA in terms of foreign cargo tonnage and 9<sup>th</sup> largest in terms of dollar value.

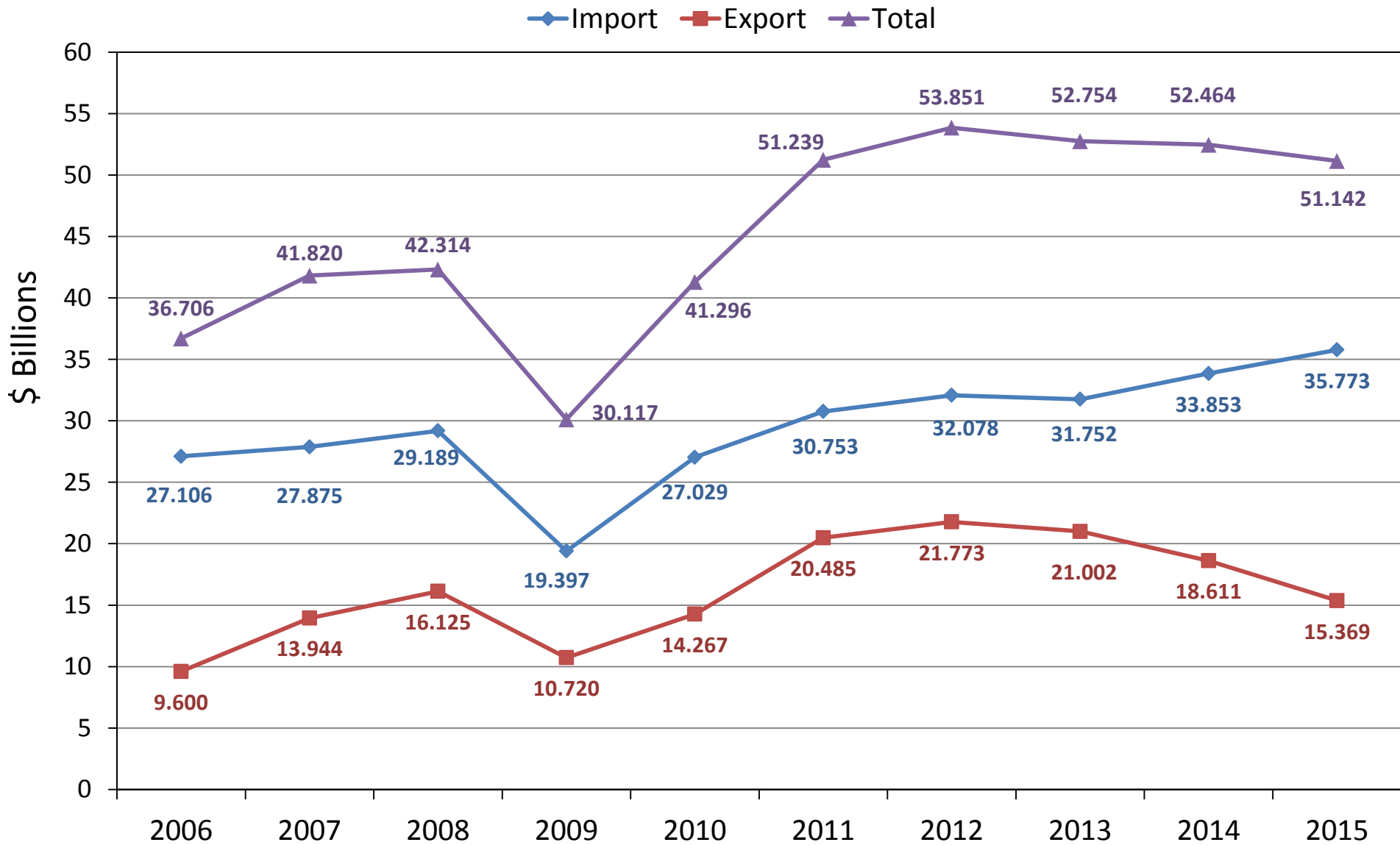
## Definitions:

Foreign Cargo excludes domestic cargo that moves between U.S. ports and between the U.S. mainland and its territories (i.e. Puerto Rico). The U.S. Army Corps of Engineers reports domestic cargo shipments for the U.S. ports, but this data is not made available until nearly a year after the Census Bureau's foreign cargo data is released.

The vast majority of domestic waterborne cargo within the Port of Baltimore consists of coal, petroleum products, sand and gravel moving within the Chesapeake Bay or to nearby ports along the U.S. East Coast.

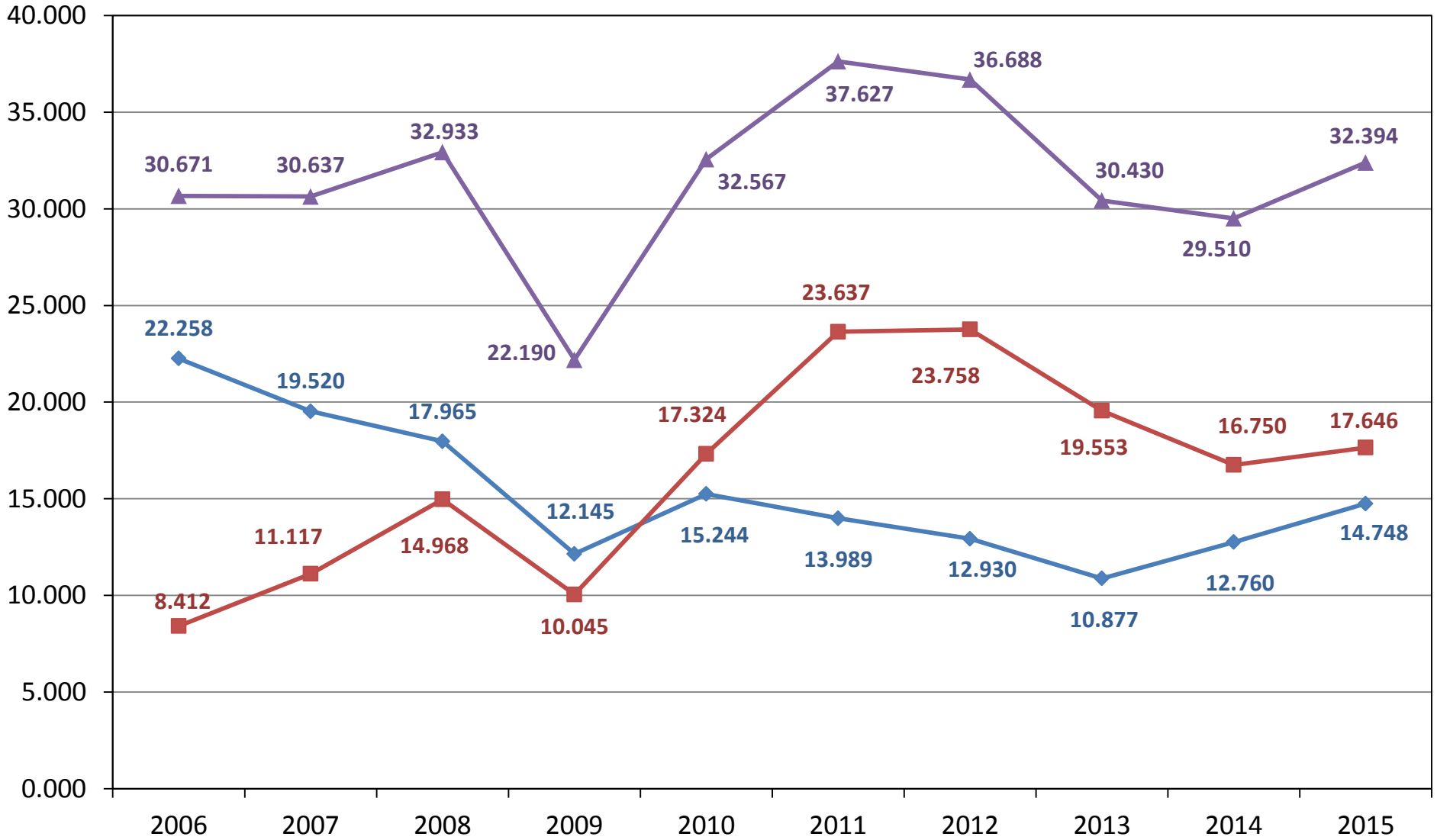
The U.S. Census Bureau's data used in this report compiles data by ports within the U.S. When ranking ports on a national basis, ports operating under the same port authority are combined, such as New York / Newark and Savannah / Brunswick.

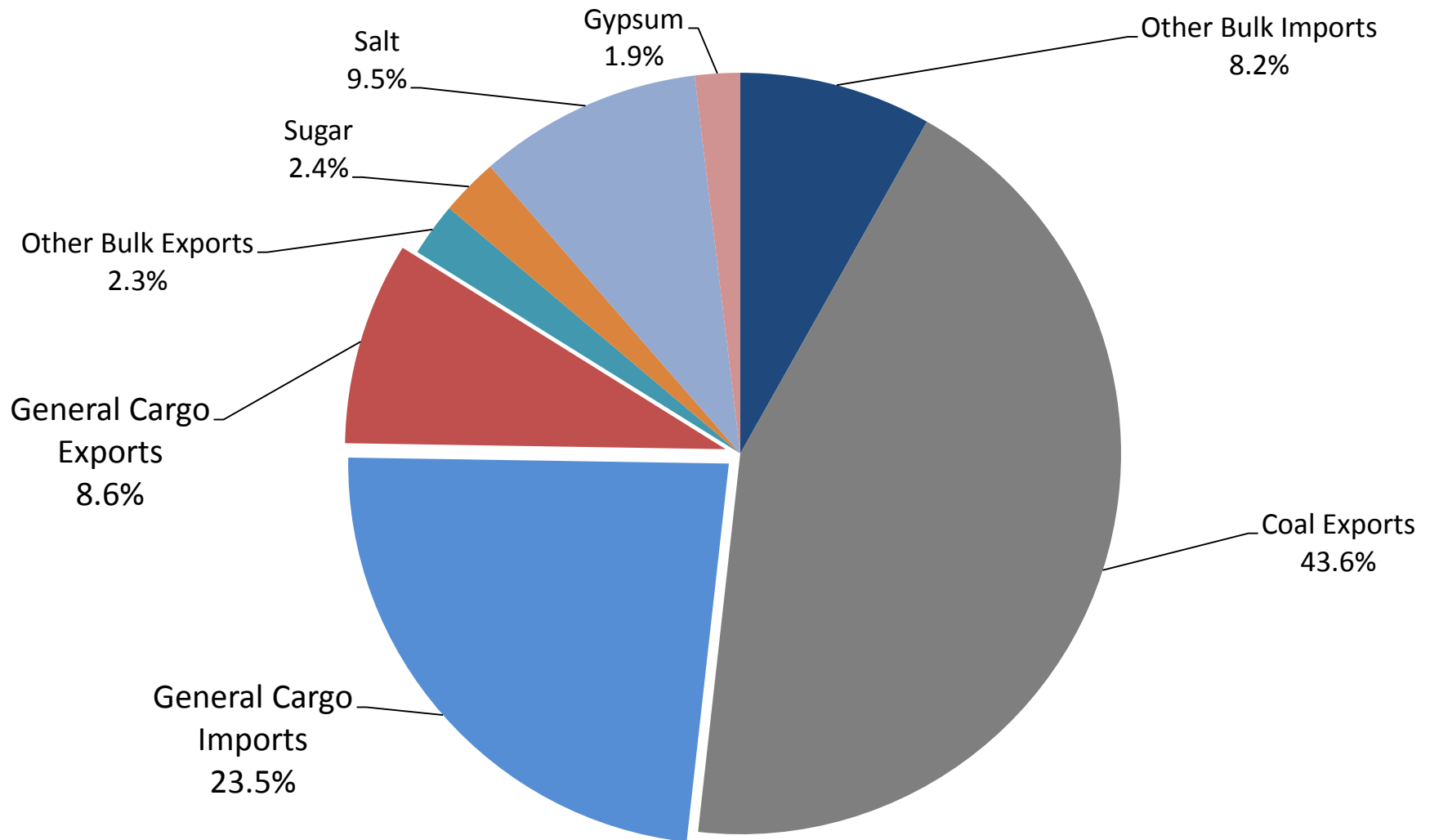

While General Cargo Tons represent approximately 32% of the Port of Baltimore overall foreign cargo tons, they make up approximately 95% of its foreign cargo value.

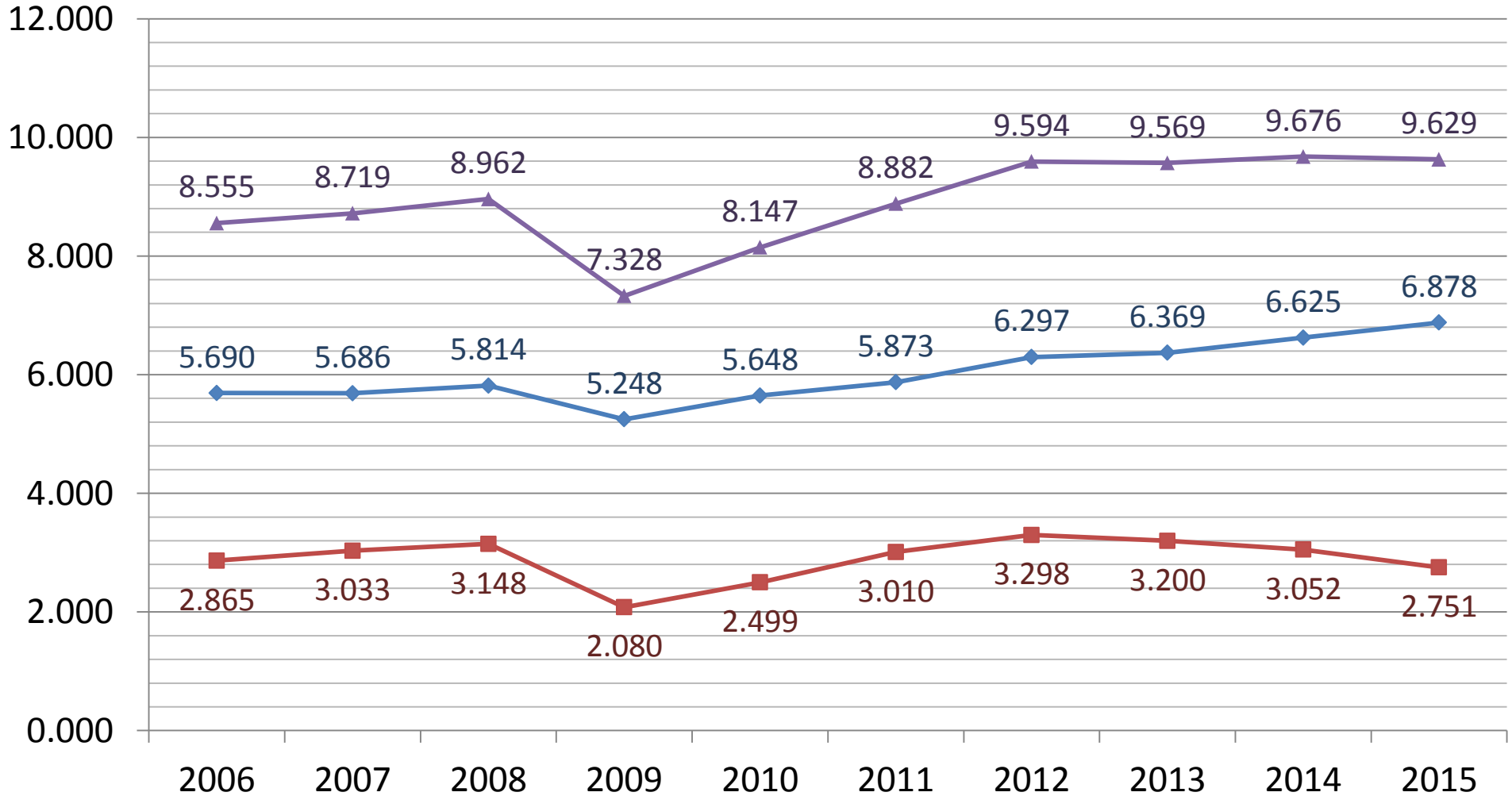

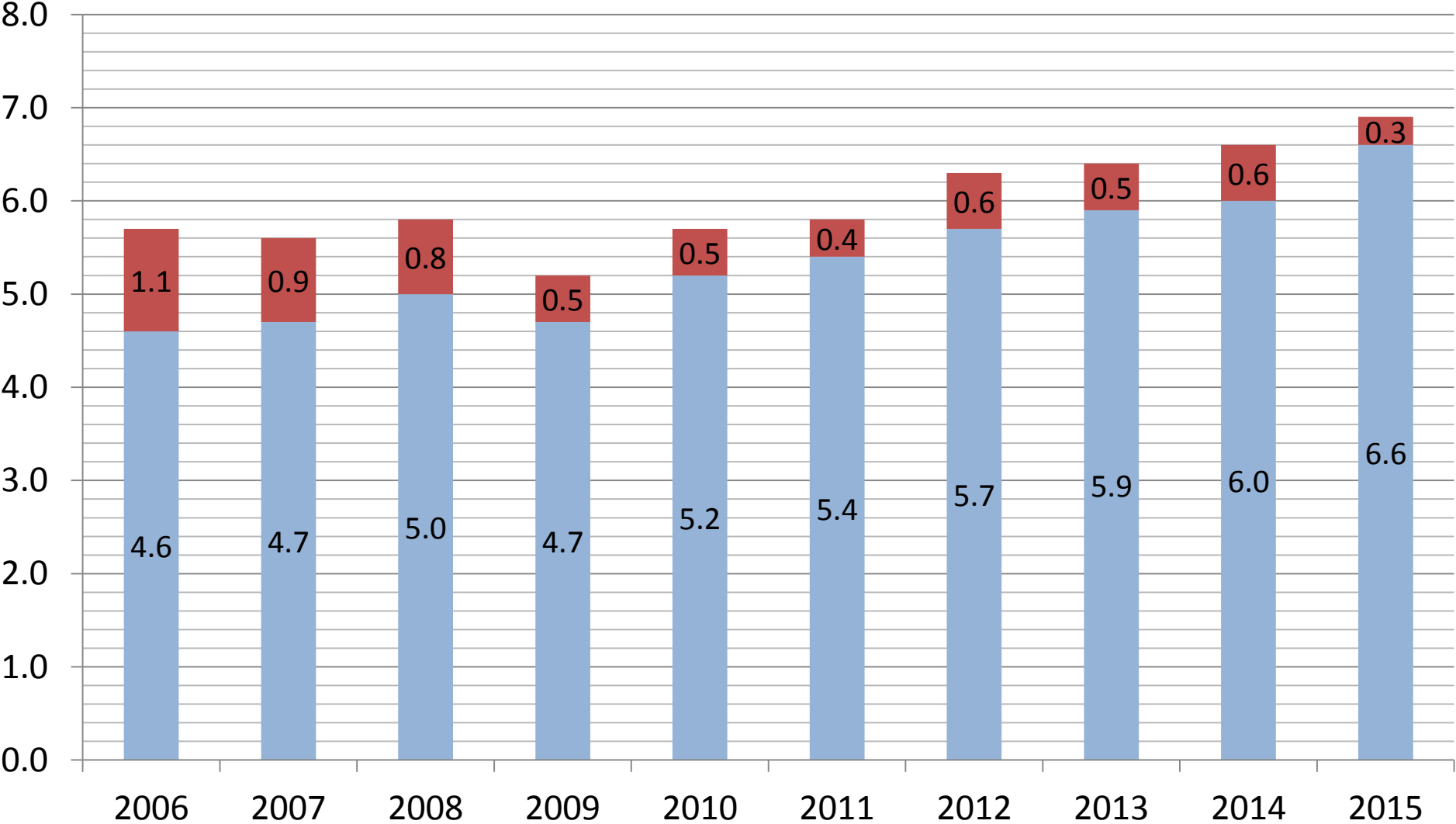
# Maryland Port Administration Terminals – General Cargo (millions of tons)

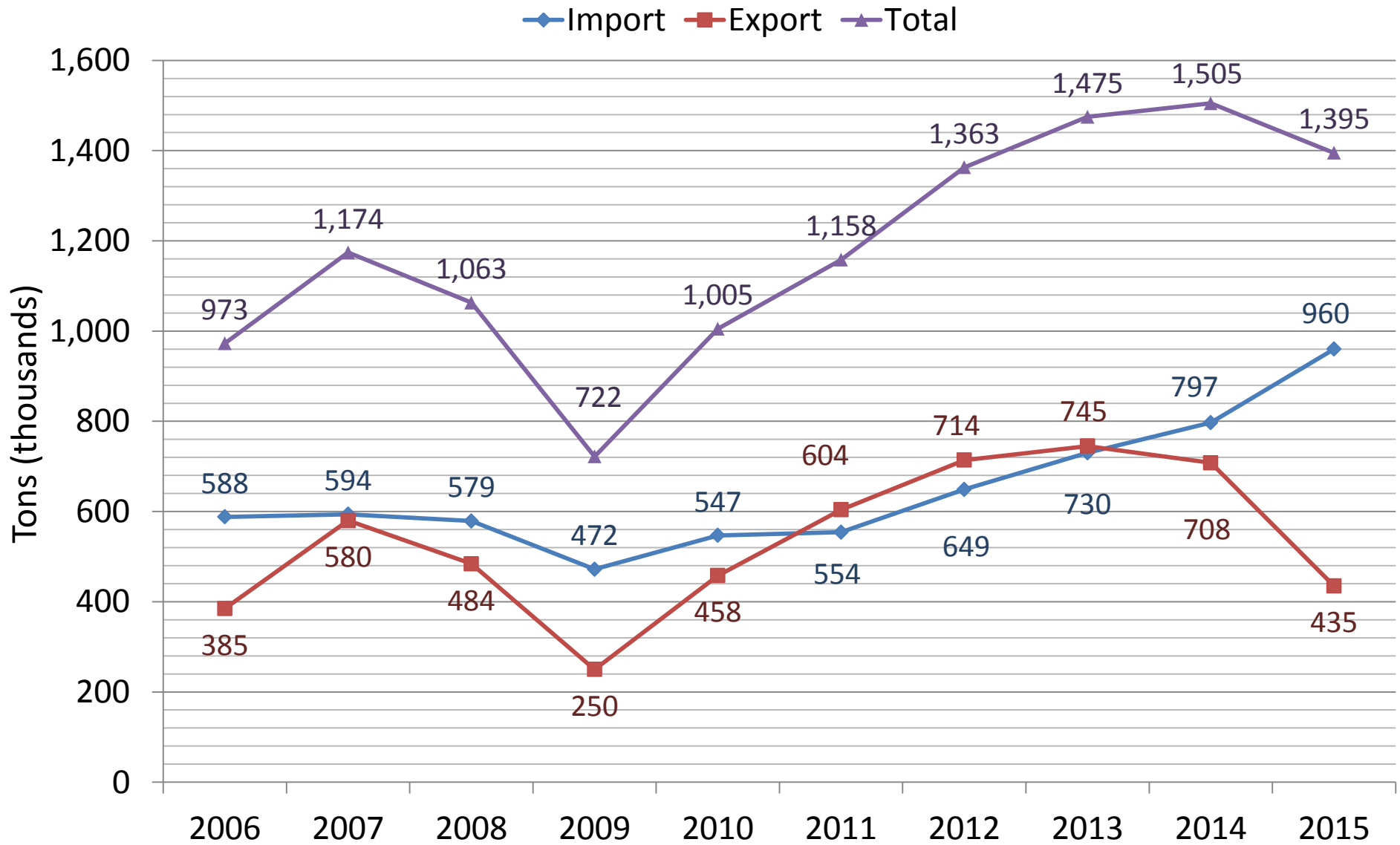
