

**PROCUREMENT OFFICER'S DETERMINATION
INTERGOVERNMENTAL COOPERATIVE PURCHASING
CONTRACT NO. P3100834
POWER DISTRIBUTION UNITS**

I. EXECUTIVE SUMMARY

This Determination has been executed pursuant to COMAR 21.05.09, Intergovernmental Cooperative Purchasing, to procure Power Distribution Units ("PDUs") for the MDOT MPA under an Intergovernmental Cooperative Purchasing Agreement of the Department of Information Technology (DOIT), Hardware 2012 Master Contract No. 060B2490022, Functional Area I and to recommend a contract award to EN-NET SERVICES, L.L.C. ("ENNET Services") in the amount of \$73,116.99. This solicitation was designated as a Small Business Reserve (SBR) contract.

III. BACKGROUND

The Maryland Department of Transportation, Maryland Port Administration (MDOT MPA) is purchasing new PDUs to replace existing devices that have reached the End of Life (EOL) and/or End of Sale (EOS) and to install on equipment that did not previously have PDU protection. The PDUs are used in the MDOT MPA data centers as support to strengthen its IT infrastructure.

Below is a detailed list of the equipment being purchased.

Twelve (12) SBR Master Contractors were solicited via DOIT's Hardware 2012 Master Contract No. 060B2490022 on May 20, 2021, and two (2) proposals were received on May 28, 2021. The MDOT MPA Information Services Department has deemed "ENNET Services" financial proposal fair and reasonable and recommends the vendor for award. I concur with the recommendation of ISD.

IV. DETERMINATION

- A. The DOIT Hardware 2012 Master Contract meets the requirements of an intergovernmental cooperative purchasing agreement under COMAR 21.05.09.01B(2)(a).
- B. "ENNET Services" price represents a savings of \$25,338.01 over the manufacturer's APC suggested retail price for the PDUs. Therefore, it is in the best interest of the State for MDOT MPA to utilize the DOIT contract because doing so will provide cost benefits to the State, will promote administrative efficiencies, and is not intended to evade the purposes set forth under COMAR 21.01.01.03.
- C. The award amount is within the funding available.
- D. A contract should be awarded to EN-NET SERVICES, L.L.C in the amount of \$73,116.99 for the purchase of PDU devices.
- E. Since this procurement constitutes a procurement of information technology supplies for which MDOT MPA has an unlimited delegation of procurement authority from the Board of Public Works (the "BPW"), approval of the award by the Maryland Port Commission and the BPW are not required.
