# Maryland Port Commission Open Session Minutes January 5, 2021

The Three Hundred and Seventy Second Session of the Maryland Port Commission was called to order at 9:02 am by Secretary Greg Slater via teleconferencing. The Commission met in Open Session from 9:02 until 10:03 am.

### Minutes of the Three Hundred and Seventy First Open Session Meeting

Commissioner McDonald moved to approve the Open Session Minutes of the Three Hundred and Seventy First Port Commission meeting. Commissioner Richardson seconded the motion. The minutes were approved unanimously without discussion.

## Executive Director Update, William P. Doyle, Executive Director

Mr. Doyle provided a business update and remarked that the Port has been and continues to remain open during the pandemic with vigilant advocacy of Covid-19 safety measures in place. Longshoreman continue to adhere to strict protocols including social distancing, mask wearing, and personal hygiene.

The Executive Director reported that the Port of Baltimore continues with very positive cargo numbers trending upwards during the Covid-19 pandemic off the lows of May and June. Highlights of Mr. Doyle's presentation included:

- Automobiles/light trucks increased 173% from lows in May.
- General cargo increased 26% from lows in June.
- Ro/Ro increased 19% from lows in June.
- Containers increased 19% from lows in June.
- Containers and general cargo experienced year over year monthly gains for the second consecutive month over 2019 with containers up 11% and general cargo up 4.1% over November 2019.

New and increased port business covered in Mr. Doyle's presentation included:

- The Metsa Group of Finland contract begins January 2021.
- Mercedes Benz is processing 600 units per day with consumer demand up.
- Maryland Port Administration (MPA) welcomed the maiden voyage of Wallenius Wilhelmsen Tannhauser, the third High Efficiency Roll on/Roll off vessel to join their fleet.

Mr. Doyle thanked Secretary Slater for his support in advancing \$34 million in funding for the reconstruction of Dundalk Marine Terminal Berth 3 that was approved at the Board of Public Works Meeting held on December 16, 2020. Seagirt Marine Terminal dredging continues on Berth 3 through winter 2020/2021, Super Post-Panamax Cranes will arrive at Seagirt for Ports America Chesapeake, and Berth 3 is expected to be operational by Summer 2021. Mr. Doyle also noted that Cruise Lines International is continuing its No-Sail Order and while there is no expected date for a return to cruise for the Port of Baltimore, MPA staff are communicating with Carnival and Royal Caribbean Cruise lines on a daily basis.

In closing, the Executive Director thanked all MPA employees for continuing to do a great job through challenging times.
